May kindly see the above office note dated 11.12.2020 regarding grant of permission to Sushri Priti Srivastava-III, Additional District & Sessions Judge, Mirzapur, by which she has requested for grant of permission to visit Dubai alongwith her son in winter holidays between 25.12.2020 to 31.12.2020, wherein inadvertently, in first paragraph of the note, the dates of proposed visit is mentioned 25.12.2019 to 31.12.2019, however, in proposal paragraph, the same is written correctly. The said office note is approved by Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Mirzapur as per proposal of the same, wherein the correct dates of proposed visit is mentioned. The contents of office note is being submitted herein below with due correction in the same:

May kindly see the online application of Sushri Priti Srivastava-III, Additional District & Sessions Judge, Mirzapur, by which she has requested for grant of permission to visit Dubai for alongwith her son in winter holidays between 25.12.2020 to 31.12.2020.

In her letter, Sushri Srivastava has stated that she wants to visit Dubai during winter holidays between 25.12.2020 to 31.12.2020 alongwith her son. The estimated expenditure of 4 days visit to Dubai as per package is approx. Rs. 1,20,000/- only, which will be bore by her from her salaried account. Photocopy of her & her son passport, bank statement of her salaried account(Bank name- State Bank of India, Account No. 32570439325) is attached alongwith her application form for kind perusal. She has also submitted the following information/declarations regarding her abroad visit:-

1. That by her abroad visit, no dilemma is likely to create before the Central Government or the Government of U.P.
2. That such request for abroad visit was not refused to her earlier.
3. That she has not visited any foreign country earlier.

She has therefore requested for grant of permission to visit Dubai in winter holidays between 25.12.2020 to 31.12.2020 alongwith her son.

In this connection, it is submitted that as per reports, no departmental/ vigilance enquiry is pending against Sushri Priti Srivastava. Permission to visit foreign country is considered vide G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999 and this Court's Circular letter no. 16/ IVf-101/Admin (A) dated 27.05.2017. As per the G.O. and relevant C.L. of the Court, the officer has furnished details of her Dubai visit. It is pertinent to mention here that as the officer has stated that her visit falls during winter vacation i.e. in the month of December 2020, seeing the Court's C.L. dated 27.05.2017, approving guidelines that abroad tour by any officer shall not be availed during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/herself, spouse or dependent, or in special circumstances and tours which are sponsored and/or approved by the State/Central Government during certain fixed span of time and does not fall during vacations. In these eventualities the Judicial Officers shall seek permission before applying for VISA. As the tour of the officer appears to be a personal trip and also falls during winter vacation in the month of December 2020, if His Lordship deem fit and proper, her

request may be considered. It has been provided that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorized by Hon'ble the Chief Justice. Recently vide order dated 19.10.2020, Hon'ble The Chief Justice has recently nominated Hon'ble Mr. Justice Pritinker Diwaker for the purpose.

In this connection, it is submitted that Hon'ble The Administrative Judge, Mirzapur has already approved the proposal of office note dated 11.12.2020 regarding officer's visit in winter vacation of December 2020 and as such, the matter is likely to be submitted again to Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge for the purpose only now.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge for the purpose, for kind perusal and orders and, if His Lordship approves, Sushri Priti Srivastava-III, Additional District & Sessions Judge Mirzapur may be granted permission to visit Dubai in winter vacation between 25th December to 31st December 2020 along with her son, as requested, and as already approved by Hon'ble The Administrative Judge, Mirzapur, with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
