May kindly see the online application of Smt. Mehnaz Khan, Addl. Civil Judge (Jr. Div.), Amroha regarding grant of permission to visit Dubai to meet her husband. The period of stay is 15 days in the month of February 2021, for which she will apply earned leave in case this Honorable High Court is pleased to grant her this permission.

In her application, Smt. Mehnaz Khan has stated that she wants to travel Dubai to meet her husband. The period of stay is 15 days in the month of February 2021. The estimated cost of the journey will be around 1.5 lakhs (Rs. one lakh fifty thousand) which will be bore by her husband. Her husband, Mr. Buland Khan is a permanent employee in Emirates Islamic Bank in Dubai, his present salary in Indian currency is Rupees 1,40,000/-(Annexed 3). Photocopy of her passport, her husband passport, her bank statement, her husband bank statement, two visa of her previous visit, and current visa is attached alongwith her application form for kind perusal. She has added that she has traveled Dubai twice before joining the service, the details of the same is attached in annexure (7). Her visit is completely personal and during the aforesaid period she will take earned leave. She has further stated that by her abroad visit, no dilemma is likely to create before the government of India or government of Uttar Pradesh. She has, therefore, requested to the Hon'ble Court for grant of permission to visit Dubai to meet her husband. The period of stay is 15 days in the month of February 2021.

She has also made the following declarations of her visit, which are as follows:-

1. That by her abroad visit, no dilemma is likely to create before the Government of India or before the Government of U.P.
2. That such type of request for abroad visit was not refused to her earlier.
3. She has traveled Dubai twice before joining the service, the details of the same is attached in annexure (7).

She has, therefore, requested for grant of permission to visit Dubai to meet her husband. The period of stay is 15 days in the month of February 2021.

In this connection, it is submitted that as per reports, no departmental/ vigilance enquiry is pending against Smt. Mehnaz Khan. Permission to visit foreign country is considered vide G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999 and this Court's Circular letter no. 16/ IVf-101/Admin (A) dated 27.05.2017. As per the G.O. and relevant C.L. of the Court, the officer has furnished details of her Dubai

visit. It is pertinent to mention here that as her visit is in the month of February 2021 i.e. her Dubai visit includes all official/ working days except Second Saturday and Sunday and its upto the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Amroha to grant her permission to visit Dubai in the month of February 2021 seeing the Court's C.L. dated 27.05.2017, approving guidelines that *abroad tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/herself, spouse or dependent, or in special circumstances and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacations. In these eventualities the Judicial Officers shall seek permission before applying for VISA.* But as the officer has stated that she wants to visit Dubai to meet her husband, thus the tour of the officer appears to be a personal trip, if His Lordships deem fit and proper, her request may be considered. It is also submitted that vide the aforesaid C.L. date 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Recently vide order dated 19.10.2020, Hon'ble The Chief Justice has nominated Hon'ble Mr. Justice Pritinker Diwaker for the purpose.

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Amroha Judgeship for kind perusal and orders and if His Lordship approves:-

(a) Smt. Mehnaz Khan, Addl. Civil Judge (Jr. Div.), Amroha may be granted permission, to visit Dubai to meet her husband. The period of stay is 15 days in the month of February 2021 as requested, subject to approval by Hon'ble Mr. Justice Pritinker Diwaker, Nominated Judge for the purpose as per Court's C.L.dated 27.05.2017 and as per recent order dated 19.10.2020 regarding

nomination of Hon'ble Mr. Justice Pritinker Diwaker, as mentioned above, with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
