May kindly see the online application of Smt. Nupur, Additional District Judge (FTC), Banda regarding grant of permission to accept gift/transfer of a NPB .22 bore Revolver from her father.

In her application, Smt. Nupur has stated that sometimes she travels alone to home town Moradabad from the place of her posting. Being female officer and due to the nature of her work, she has applied for an arm license & the same was issued to her on 19.11.2020 bearing UIN No. 330021003107182020. Her father Sri Brij Nandan Sharma wishes to gift her a NPB .22 bore revolver bearing no. 125105837, Make Indian, which is owned by him since 08.01.2015. Presently, her father is 72 years old & having a 315 bore rifle, a 12 bore double barrel gun & a .22 bore revolver licensed in his name. As per the U.P. Govt. order 3/2020/G.I.-187/Cha-Pu-5-2020-1(12)/2015 issued in compliance of amendment in relevant provisions of Arms Act that the third arm has to be deposited by the license holders. As per the aforesaid order, now her father cannot keep the three arms. It is also pertinent to mention here that her brother also has a Revolver licensed in his name & for these reasons & due to love & affection, her father wishes to gift/transfer the .22 bore revolver to her. (Copy of license of the officer as well as her father, consent letter of her father, receipt & G.O. can be seen as attachments). She has, therefore, requested for grant of permission to accept the gift/transfer of NPB .22 bore revolver bearing serial no. 125105837 Make Indian, so that she may acquire the arm for her safety needs.

In this connection, the relevant extract of rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) is as under:-

11. Gifts:- A government servant shall not without previous approval of Government :-

(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or

(b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.

In this connection, it is submitted that as the revolver is to be gifted to the officer by her father out of natural love and affection, it amounts to be a gift from close blood relative, which is permissible under Rule 11.

Furthermore, the request of the officer appears to be considerable, as she has requested for prior permission for the transaction.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Ali Zamin, Nominated Judge for disposal of the matters of Judicial Officers, of information/ permission of sale/purchase of movable/immovable property or gift etc. for the District Banda, for His Lordship's kind perusal and if His Lordship approves, Smt. Nupur, Additional District Judge (FTC), Banda be granted permission to accept gift/transfer of a NPB .22 bore Revolver bearing no. 125105837 from her father Sri Brij Nandan Sharma, as requested, subject to the condition that relevant papers of the transaction be submitted by her on completion of the transaction?
