May kindly see letter dated 18.01.2021 alongwith attested copy of mark-sheet (both semesters) and degree of LL.M (**online attached on 18.01.2021**) of Sri Shubham Chaudhary, Addl. Civil Judge (Junior Div.), Firozabad, requesting for inclusion of LL.M qualification in his service-records.

Sri Shubham Chaudhary, aforesaid, had earlier requested for grant of Three Advance Increments vide District Judge, Firozabad endorsement no. 2649/XV-2020 dated 31.10.2020 (**offline mode**). Additionally, he has uploaded attested copies of Degree and mark-sheet of LL.M. qualification in online mode through eServicesJO portal, accompanied with prayer for inclusion of the same in his service-records (**online attached on 18.01.2021**).

In this context, it is submitted that Sri Shubham Chaudhary, aforesaid, joined U.P.Judicial Services on 16.12.2019 as Addl. Civil Judge (Junior Div.), Firozabad. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M (**online attached on 18.01.2021**), Sri Shubham Chaudhary, completed LL.M course in year 2019 and was subsequently awarded Degree from Dr. Ram Manohar Lohia National Law University, Lucknow on 10.07.2019. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Shubham Chaudhary, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 18.01.2021(**online attached on 18.01.2021**) of Sri Shubham Chaudhary, Addl. Civil Judge (Junior Div.) Firozabad, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Ved Prakash Vaish, Administrative Judge, Firozabad, for kind perusal and order to the effect that copy of aforesaid letter dated 18.01.2021 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 18.01.2021**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Shubham Chaudhary, Addl. Civil Judge (Junior Div.) Firozabad, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
