May kindly see online request dated 22.01.2021 accompanied with application dated 20.01.2021(Attachment 1 Page 2) and other essential documents(submitted as attachments) of Sri Mridulesh Kumar Singh, District & Sessions Judge, Etah regarding sanction of final withdrawal of Rs.20,00,000/- to him out of the total amount standing to his credit in G.P.F Account No. LJU-19064, to meet out the expenses due to arise in upcoming marriage of his Son, Mr. Anubhav Singh.

Sri Mridulesh Kumar Singh has informed vide certificate dated 27.01.2021(Attachment 2) that the marriage of his Son Mr. Anubhav Singh with Ms. Shikha Singh, D/o Sri R.P.Singh R/o Pratapgarh(U.P) is due to be solemnized on 30.04.2021. Thus, he has requested for sanction of Rs.20,00,000/- from his GPF account.

In this connection it is submitted that the aforesaid request of Sri Mridulesh Kumar Singh may be considered under provision of Rule 16(1)(A)(b) of G.P.Fund(U.P) Rules, 1985, which is as follows :

Rule 16(1)(A) : After the completion of twenty years of service (including period of suspension followed by reinstatement and other broken periods of service, if any) of a subscriber or within 10 years before the date of his retirement on superannuation, whichever is earlier, from the amount standing to his credit in his GPF Account for one or more of the following purposes, namely:

(b) meeting the expenditure in connection with the marriage of the subscriber's son or daughter, and any other relation actually dependent on him.

Sri Mridulesh Kumar Singh has also attached attested photo-copy of last six, including current F.Y., GPF pass-book statements and certificate dated 20.01.2021(Attachment 1 Page 7), issued by the Drawing and Disbursing Officer, Etah as the evidence of total amount standing to his credit in his GPF Account No. LJU-19064 till January, 2021. As per GPF pass-book statement for the F.Y 2019-20(Attachment 1 Page 13) & 2020-21(Attachment 1 Page 14) and certificate issued by the Drawing and Disbursing Officer, Etah, a total amount of Rs.51,83,428/- stands to his credit in his GPF Account till 20th January, 2021, out of which final withdrawal of Rs.20,00,000/- can be sanctioned.

He has also informed vide certificate dated 20.01.2021(Attachment 1 Page 4)that he has not taken any final withdrawal in his entire service-period till date. Further, vide certificate dated 20.01.2021(Attachment 1 Page 3) he has informed that he has taken three temporary advances from his G.P.F Account, all of which have already been recovered and accordingly debited from said G.P.F A/c. He had joined U.P.Judicial services on 08.10.1990 and is due to retire on 31.07.2021. His current Pay is Rs.73,370/-.

Final Withdrawal of Rs.20,00,000/- may be sanctioned to Sri Mridulesh Kumar Singh from his GPF Account No. LJU-19064, for meeting out the expenses due to arise in upcoming marriage of his son, as a special case, in terms of sub rule 16(1)(A)(b) read with 17(1)(a), which allows sanction of withdrawal up to 3/4th of the balance at the credit of officer in the Fund, of G.P.Fund(U.P) Rules, 1985, subject to the following conditions :

1. That the amount shall not be withdrawn unless it is actually required for the purpose and it shall not be utilized for any other purpose.
2. That a utilization certificate shall be furnished to the Court within the time allowed in rule.
3. That the amount sanctioned for marriage shall be utilized within 3 months from the date of withdrawal.

4. That the Treasury Officer, Etah shall ensure to mention the amount of Final Withdrawal in the withdrawal column of GPF pass-book of Sri Mridulesh Kumar Singh, without delay.
5. That as per undertaking(Attachment 1 Page 6), issued by Sri Mridulesh Kumar Singh under his own signature and seal, duly attested by D.D.O., Etah, any excess payment made in his favour shall be returned by him immediately to the concerned authority/account.

In the view of above submitted facts and information, if approved by Learned Joint Registrar(Judicial)(Budget), instant request of Sri Mridulesh Kumar Singh, District & Sessions Judge, Etah may kindly be placed before Hon'ble Mr. Justice Om Prakash-VII, for His Lordship's kind perusal and order to the effect that an amount of Rs.20,00,000/-(Twenty Lacs) only as final withdrawal may be sanctioned to Sri Mridulesh Kumar Singh, District & Sessions Judge, Etah against his GPF Account No. LJU-19064, for meeting out the expenses relevant with marriage of his son, as a special case, in terms of sub rule 16(1)(A)(b) read with 17(1)(a) of G.P.Fund(U.P) Rules, 1985, subject to the conditions mentioned above ?

१. एतद्वारा श्री/श्रीमती/कुमारी शुद्धेश कुमार सिंह को उनके सामान्य भविष्य निधि खाता संख्या एन०जे०यू० 19064 से ५५० क. प्रयोजन के व्यय वर्द्धन करने हेतु 20,00,000/- रूपये (शब्दों में) दो करोड़ का अंतिम निष्कासन सामान्य भविष्य निधि (ज०यू०) नियमावली, १९८५ के नियम संख्या 16(1)(A)(b) अर्थात् 17(1)(a) के अनुसार स्वीकार किया जाता है।

२. अंतिम निष्कासन की धनराशि श्री/श्रीमती/कुमारी शुद्धेश कुमार सिंह को ~~उनके बैंक खाते में जमा~~ अर्थात् निधि में जमा अवशेष के आधे/तीन चौथा भाग से अधिक नहीं होगी। मूल नियमावली (फण्डामेंटल रूल) में यथापरिभाषित उनका मूल वेतन 73,390/- रु० है।

३. यह प्रमाणित किया जाता है कि श्री/श्रीमती/कुमारी शुद्धेश कुमार सिंह ने दिनांक 07-10-2000 को अपनी सरकारी सेवा को ~~समप्त~~/बीस वर्ष पूरे कर लिये हैं, १० वर्ष में अधिवार्षिकी पर सेवा निवृत्त होंगे/होंगी।

४. दिनांक 22.01.2002 को उपलब्ध कराये गये अभिलेख की स्थिति के अनुसार श्री/श्रीमती/कुमारी शुद्धेश कुमार सिंह के खाते में जमा अवशेष राशि का ब्योरा निम्न प्रकार है।

- (३) माह 1/10, 20 से माह 1/11, 20 तक प्रतिमाह रु० A. A. Annex 73,242 की दर से अधिसान की गसूली रु० 73,242
- (४) मद (१), (२) तथा (३) का योग रु० 51,83,428/-
- (५) बाद में स्वीकृत अंतिम निष्कासन, यदि कोई हो रु०
- (६) स्वीकृत प्रदान करने की तिथि को अवशेष मद (४) में से मद (५) घटाइये रु०
- (क) वर्ष 2019-20 की लेखा-पर्ची के परचात इस कार्यालय द्वारा श्री/श्रीमती/कुमारी शुद्धेश कुमार सिंह को पिछली बार आदेश संख्या 19064 दिनांक 07-10-2000 द्वारा 5000 रु० का कोड अंतिम निष्कासन स्वीकार नहीं किया गया था।
- (ख) ज्ञात हुआ है कि श्री शुद्धेश कुमार सिंह को (जैसा कि उन्होंने बताया) शुद्धेश कुमार सिंह (स्वीकृत कर्ता) द्वारा पिछली बार अंशतः अंतिम निष्कासन के रूप में रु० 5000 की स्वीकृत प्रदान की गई थी।
