May Kindly see the online application, of Sri Abhishek Sharma, Addl. Civil Judge (Jr. Div.), Mathura by which he has requested grant of permission to apply for and to appear in the Preliminary Examination of Haryana Civil Services (Judicial Branch) Examination- 2020-21 for the post of Civil Judge (Jr. Div.), to be conducted by Haryana Public Service Commission.

In his application, Sri Abhishek Sharma has stated that he wishes to apply for and to appear in the Preliminary Examination of Haryana Civil Services (Judicial Branch) Examination- 2020-21 for the post of Civil Judge (Jr. Div.), to be conducted by Haryana Public Service Commission. The preliminary examination is anticipated to be held in the month of April 2021, tentatively. Further, the officer has also stated that on 13.01.2021 the advertisement for the application was issued. He has also sent the notification and instructions as attachment. He is native of Panipat (Haryana) and his family resides there. If he be allowed to serve there, he will be in a better position to take care of them. He has, therefore, requested the Court to permit him to apply for and to appear in the aforesaid examination.

In this connection, it is submitted that the officer has joined U.P. Judicial Services on 24.12.2019. Now, It is desirable that he may be accorded permission to apply for and to appear in the Preliminary Examination of Haryana Civil Services (Judicial Branch) Examination- 2020-21 for the post of Civil Judge (Jr. Div.), to be conducted by Haryana Public Service Commission, the preliminary examination is anticipated to be held in the month of April 2021 (tentatively), if the Court so desires. Permission to appear in such type of written examination may be accorded, but subject to the following conditions:-

1. Government work should not suffer in any way.
2. No preferential treatment will be given in the matter of leave, postings and transfer.
3. The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.

May, therefore, if approved by Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Mathura Judgeship, permission be accorded to Sri

Abhishek Sharma, Addl. Civil Judge (Jr. Div.), Mathura to apply for and to appear in the Preliminary Examination of Haryana Civil Services (Judicial Branch) Examination- 2020-21 for the post of Civil Judge (Jr. Div.), to be conducted by Haryana Public Service Commission, as requested, subject to the conditions mentioned above?
