May kindly see the online application received from Smt. Shazia Nazar Zaidi, Principal Judge, Family Court, Jaunpur by which she has submitted supplementary details in connection with information about purchase of a new Honda BR-V car in compliance of Court's order.

In this connection, it is submitted that earlier the officer has informed about purchase of a new Honda BR-V car for Rs. 11,78,900/- through her online applications dated 04.12.2019, 06.12.2019 & 23.01.2020. The matter was submitted before Hon'ble Mr.Justice Virendra Kumar - II, vide detailed office note dated 29.01.2020 for approval/ orders, upon which His Lordship has been pleased to pass following order:

"The officer Smt. Shazia Nazar Zaidi, Principal Judge, Family Court, Jaunpur has sent information about purchase of a new Car Honda BRV on 30.8.2019 from a renowned dealer, namely Honda Showroom, 36, Jajpat Nagar Maldhiya Varanasi of costs amounting to Rs. 11,78,900/-. She took loan amounting to Rs. 7,00,000/- from Syndicate Bank and she is paying installment amounting to Rs.23,000/- per month. She has to pay it in 36 installments.

The officer has provided statement of account of her saving bank, but there is no entry regarding transfer of installment to the loan account.

The statement of loan account has not been provided, therefore, it is not clear that how officer is paying installment of Rs.23,000/- to the bank. The officer has withdran money through ATM, every month. Therefore, she has to clarify by which means, she is depositing installment of car loan. The report be submitted within fifteen days. She has to disclose her household expenses and liabilities also."

The order was communicated to the Officer through online mode on 03.03.2020.

In reply to the objection raised by this Court on 03.03.2020, Smt. Shazia Nazar Zaidi has humbly submitted that her car loan installment was due from 30.09.2019 and loan

installments are deducted from her saving bank account in Syndicate Bank to the loan

account No. 86919390000010 of Syndicate Bank. Uptill now installments are deducted

on 01.10.2019, 30.10.2019, 30.11.2019, 31.12.2019, 31.01.2020 and 29.02.2020 (Loan

Sanction letter and relevant entries of her passbook are attached here with).

She has also submitted that she has two sons (aged about 13 years

and 9 years) studying in class 9 and class 3 and her husband is a

practicing lawyer at New Delhi and both jointly share their household

expenses and liabilities. Their household expenses are about Rs.

30000-35000 per month which includes their sons' school fees, tuition

fees, household grocries expenses, etc. She has taken no other loan

like house loan, personal loan, etc. except the above mentioned Car

Loan.

May, therefore, if approved, the matter be laid before Hon'ble Mr.

Justice Virendra Kumar - II for His Lordship's kind perusal & further

order for acceptance of information about purchase of a new Honda

BR-V car now?
