It is further submitted that as per Rule- 24 (2) of U.P. Government Servant's conduct Rule-1956: -

“A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority.”

Therefore, if approved, the matter be laid before Hon'ble Mr. Justice Pradeep Kumar Srivastava for His Lordship's kind perusal and if His Lordship approves, Sri Indra Jeet Singh-II, Chief Judicial Magistrate, Mirzapur may be granted permission to purchase a second hand car (Innova Crysta 2.4V) from Sri Arshad, S/o- Mohammad Wahid, R/o- E-267, Ashok Bihar Colony, Pahariya, Varanasi, Uttar Pradesh- 221007 for Rs. 10,00,000/-, as requested, subject to the condition

that the relevant papers of the transaction be furnished by him immediately on completion of the transaction?
