Registrar (J) (Budget)

May kindly see the online application of Smt. Neha Rungta, the then Addl. Civil Judge (Sr. Div.)/ACJM, Varanasi presently posted at Ghaziabad regarding issuance of 'No Objection/ Identity Certificate' in her favour for obtaining Passport.

In her application, Smt. Rungta has stated that she has a passport no. H-6208168 (copy of passport can be seen as attachment), issued to her on 03.09.2009 and the same got expired on 02.09.2019, thus she wants to renew the same for which 'No Objection/ Identity Certificate' from the Hon'ble Court is required. There are no dependent family members of the officer. She has also enclosed required details/ declaration on 'Affidavit', which may kindly be seen as attachment. The matter was put up before Hon'ble Administrative Judge, Varanasi Judgeship through detailed office note dated 22.01.2020 upon which His Lordship has been pleased to pass the following order:-

"It appears that there are some typographical errors in Clause-F of the affidavit furnished by the officer concerned.Office to look into and do the needful. "As per His Lordship's order, the officer was again asked to send the affidavit with the aforesaid amendment.

Now, in reply the officer has again sent the affidavit by making necessary amendment in Clause 'F', which can be seen as attachment. She has, therefore requested for issuance of 'No Objection/ Identity Certificate' in her favour for obtaining/ renewal of Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999. Here it is also to submit that as per the earlier reports, no vigilance/ departmental enquiry is pending against Smt. Neha Rungta. It is also pertinent to mention here that as the earlier issued passport, which was obtained by her prior to joining in U.P. Nyayik Sewa, got expired and thus she wants to renew the same. Her request is considerable, as she has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved, the instant matter may be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Ghaziabad and if His Lordship's approves, the 'Identity Certificate' be issued, offline, in duplicate, under the signature of Registrar (Judicial) (Budget) in favour of Smt. Neha Rungta, Addl. Civil Judge (Sr. Div.)/ACJM, Ghaziabad, as requested, for renewal of Passport with the direction of the Court that she should take prior permission of the Court before proceeding abroad?
