May kindly see the online application of Sushri Akanksha Garg, Addl. Civil Judge (Sr. Div.)/ ACJM, Amroha by which she has requested for grant of permission to visit Londan to attend her family wedding celebration from 13.05.2020 to 30.05.2020.

In her application, Sushri Garg has stated that her real uncle Sri Rajesh Kumar Garg has been permanently living at 3042, Liana Lane, Pensacola, Florida 32505, U.S.A. The wedding ceremony of his brother (Uncle's son) has been finalized with Dr. Poonam on 17.05.2020 at Hilton Londan, Syon Park, Park road, Isleworth, TW8 8JF, Londan, U.K. (marriage card can be seen in attachment). She has also stated that she would go to that ceremony alongwith her father Sri Devendra Kumar Garg, Rt. D.J. and current President of District Consumer Forum-I, Moradabad and mother Smt. Mukta Garg. The marriage/wedding rituals will commence from 14.05.2020, therefore, she has to leave on 13.05.2020 from here and after approx. 6 days of marriage programme, her uncle would make her and other relatives visit to London (U.K.) and other European countries (Belgium, Germany, Switzerland, France, Italy etc.). Furthermore, her father draws 1,56,226/- p.m. Salary and 32,733/monthly pension i.e. in total he draws 1,88,959/- per month and he would bear her mother and his own expenses of visit. Her visit to and from to London would cost approx. 57,166 and other possible expenses Rs. 50,000/-, in total Rs.1,07,166/- would be the approximate expenses of her tour (supporting papers can be seen as attachments) which would be borne from her salary S.B. A/c no. 20071032995 which shows the balance amount od RS. 5,77,280/- as salary savings. The expenses of fooding and lodging would be borne by his Uncle (supporting papers can be seen as attachment). She has further added that she would take earned leave, for which she would submit separate application to this Court and she also has a valid passport which is valid till 28.10.2020 and she has also applied for the renewal of the same (supporting papers can be seen as

attachment). She has also submitted the following details/declarations realted to her visit:-

- 1. From her proposed foreign visit, no dilemma is likely to create before the government of India or the government of U.P.
- 2. Such type of request of foreign visit was never refused to her.
- 3. She has never visited any foreign country earlier.

She has, therefore, requested to place her application for grant of permission to visit London alongwith her parents to attend wedding ceremony of her brother there from 13.05.2020 to 30.05.2020, so that she can proceed further for obtaining VISA and tickets within time.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999. As per reports, no vigilance/departmental enquiry is pending against Sushri Akanksha Garg. In this connection it is also submitted that in the Court's C.L. dated 27.05.2017, the Judicial officers may undertake pleasure trip to a foreign country during vacation/holiday only and in the instant case, the officer has requested the Hon'ble Court for grant of permission to visit London (U.K.) to attend wedding ceremony of his cousin brother (Uncle's son) and thereafter to visit some other European countries (Belgium, Germany, Switzerland, France, Italy etc.) alongwith her parents from 13.05.2020 to 30.05.2020. It is also pertinent to mention here that as she is going to be a part of her family function which is her personal/ social responsibility and she will visit some other European countries (Belgium, Germany, Switzerland, France, Italy etc.) thereafter and as the marriage and such other family occasions appears to be a social circumstances, it appears to be considerable and now it's upto all the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Amroha to grant her permission to visit there seeing the point no. (1) & (2) of resolution dated 17.05.2017 of Hon'ble Administrative Committee approving guidelines that *abroad*

tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/herself, spouse or dependent, or in special circumstances and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacations. In these eventualities the Judicial Officers shall seek permission before applying for VISA... For other reasons and for pleasure trips, the officer will be permitted to go abroad only during vacation/official holidays, for which, even before applying for VISA, prior permission should be applied at least two months prior to the proposed visit. In this connection it is also submitted that as per resolution of Hon'ble Administrative Committee meeting held on 17.05.2017, it has been resolved that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice.

Under the facts and circumstances, mentioned above, if approved the instant matter may kindly be laid before Hon'ble Justice Mr. Justice Pritinker Diwaker, Administrative Judge, Amroha and if His Lordship approves, Sushri Akanksha Garg, Addl. Civil Judge (Sr. Div.)/ ACJM, Amroha may be granted permission to visit London (U.K.) to attend wedding ceremony of his cousin brother (Uncle's son) and also to visit some other nearby European countries (Belgium, Germany, Switzerland, France, Italy etc.) alongwith her parents, from 13.05.2020 to 30.05.2020, as requested, subject to the conditions that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad and also subject to further approval by Hon'ble The Chief Justice, as per requirement of Court's C.L. No.16/ IV f-101/
