

**Registrar (J) (Budget)**

May kindly see the online application of Sri Mahendra Kumar Singh, the then Addl. Chief Judicial Magistrate, Varanasi presently posted as Civil Judge (Sr. Div.), Varanasi regarding issuance of 'Identity Certificate' in his favour for obtaining Passport.

In his application, Sri Singh has stated that he wants to apply for passport for which 'Identity Certificate' of Hon'ble Court is required. Smt. Anjane (Wife), Km. Lavanya and Km. Chaitanya (Daughters) are dependent family members of the officer. He has also enclosed required details/ declaration on 'Affidavit', which may kindly be seen as attachments. The matter was put up before Hon'ble Administrative Judge, Varanasi Judgeship, Hon'ble Mr. Justice Pritinker Diwaker through detailed office note dated 26.02.2020 upon which His Lordship had been pleased to pass the following order:-

“It appears that there are some typographical errors in Clause-F of the affidavit furnished by the officer concerned. Office to look into and do the needful. “As per His Lordship's order, the officer was again asked to send the affidavit with the aforesaid amendment.

Now, in reply the officer has again sent the affidavit by making necessary amendment in Clause 'F', which can be seen as attachment. He has, therefore requested for issuance of 'No Objection/ Identity Certificate' in his favour for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999. Here it is also to submit that as per the earlier reports, no vigilance/ departmental enquiry is pending against Sri Mahendra Kumar Singh. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved, the instant matter may be laid before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Varanasi and if His Lordship's approves, 'Identity Certificate' be issued, offline, in duplicate, under the signature of Registrar (Judicial) (Budget) in favour of Sri Mahendra Kumar Singh, Civil Judge (Sr. Div.) , Varanasi, as requested, for obtaining Passport, with the direction that he should take prior permission of the Court before proceeding abroad?
