May kindly see online request dated 18.01.2020 alongwith attested copies of mark-sheets (all semesters) and degree of LL.M (**online attached on 17.02.2020**) of Sri Manish Kumar-II, Civil Judge (Sr. Div.), Azamgarh, requesting for inclusion of LL.M qualification in his service-records.

Sri Manish Kumar-II, aforesaid, had earlier requested vide letter dated 23.10.2019 (**offline mode**), for inclusion of LL.M qualification in his service-records, thereafter, he had asked vide Court endorsement no. 18080/IV-4011/Admin.(A) dated 10.12.2019 to submit attested copies of mark-sheets (all semesters) & degree of LL.M through online portal eServicesJO. Thereafter, he has submitted/uploaded self-attested copies mark-sheets and degree of LL.M through online portal eServicesJO on 18.01.2020. Further, objection raised in instant matter by Admin-A1 for upload attested copies (not self-attested) of mark-sheets(all semesters) as well as degree of LL.M. Now, he has submitted attested copies of mark-sheets(all semesters) and degree of LL.M on 17.02.2020 (**online attached on 17.02.2020**).

In this context, it is submitted that Sri Manish Kumar-II, aforesaid, joined U.P. Judicial Services on 05.07.2013 as Addl. Civil Judge (Junior Div.), Ghazipur. Besides, as apparent from submitted attested copies of mark-sheets(all semesters) as well as degree of LL.M(**online attached on 17.02.2020**), Sri Manish Kumar-II, completed LL.M course in year 2009 and was subsequently awarded Degree from Banaras Hindu University on 26.02.2010. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in his service records. It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Manish

Kumar-II, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid earlier offline request dated 23.10.2019 of Sri Manish Kumar-II, Civil Judge (Junior Div.), Azamgarh, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Azamgarh, for kind perusal and order to the effect that copy of letter dated 23.10.2019(**offline mode**) along with attested copies of mark-sheets(all semesters) and degree of LL.M(**online attached on 17.02.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Manish Kumar-II, Civil Judge (Junior Div.), Azamgarh, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
