May kindly see the online applications of Sri Ahasan Husain, Addl. District & Sessions Judge, Saharanpur regarding issuance of fresh 'No Objection/Identity Certificate' for obtaining Passport.

In his applications, Sri Husain has stated that earlier he was issued 'No Objection Certificate' dated 20.12.2011 through Court's letter no. 274/ IV-2941/ Admin (A) dated 06.01.2012 and then he applied for the passport on 22.02.2012 which got registered in the Passport office of Lucknow as LKO-Z900077-12 dated 26.04.2012 but after the sufficient time the passport was not issued to him, therefore he applied for the closing letter on 20.08.2014, upon which he got a report from the passport office that his application got closed because police report had not been received (relating papers can be seen as attachment). Now, the officer wants to perform Haj alongwith his family and for that passport is required for which he needs 'No Objection/ Identity Certificate' from the Court. His dependent family members are Smt. Rehana Saifi (Wife), Km. Alina Husain (Daughter) and Master Aaban Husain (Son). He has also enclosed passport size photographs of himself and required details/declaration on 'Affidavit', which may kindly be seen as attachment. He has, therefore, requested to the Hon'ble Court for issuance of fresh 'No Objection/ Identity Certificate' in his favour for obtaining passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999. Earlier, as per approval of Hon'ble Administrative Judge, Chandauli dated 12.12.2011, 'No Objection Certificate' dated 20.12.2011 was issued in his favour, but as he has now requested for fresh 'Identity Certificate' due to the reason that he could not obtained passport on the earlier one due to unavailability of police report, his request may be considered. Here it is also to submit that as per latest reports, no

vigilance/ departmental enquiry is pending against Sri Ahasan Husain, at present. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved, the file may be laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Saharanpur for kind perusal and if His Lordship's approves, fresh 'Identity Certificate' be issued, offline, in duplicate, under the signature of Registrar (Judicial) (Budget) in favour of Sri Ahasan Husain, Addl. District & Sessions Judge, Saharanpur, as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
