May Kindly see the online application of Smt. Surabhi Shree Gupta, Civil Judge (Jr. Div.), Auraiya by which she has requested for 'No Objection Certificate' for appearing in the interview of Delhi Judicial Services Examination 2019.

In her application, Smt. Gupta has stated that vide endorsement number 13763/4/4495 - Adm(A-4) dated 21-09-2019 she was permitted to appear in Delhi judiciary preliminary exam and further through online portal she had applied for permission to appear in Delhi Judicial Services (Mains) Examination 2019 and in anticipation of Hon'ble Court's permission, she appeared in mains examination. Now, she has cleared Delhi Judicial Services (Main) Examination 2019, the result of which was declared on 13.01.2020 vide public notification. She has, therefore, requested Hon'ble Court to issue her 'No Objection Certificate' for appearing in the interview of Delhi Judicial Services Examination 2019.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 19.06.2018. Earlier, vide this Court's letter dated 21-09-2019 of Hon'ble the Administrative Judge, Auraiya, she had been accorded permission to appear in the preliminary exam of Delhi Judicial Services Examination, 2019. Thereafter, she submitted her application for grant of permission to appear in Delhi Judicial Services (Main) Examination 2019. It is pertinent to mention here that the detailed office note dated 16.11.2019 is put up online before Hon'ble Administrative Judge, Auraiya regarding ex-post facto permission for her appearance in Delhi Judicial Services (Main) Examination 2019 upon which no order is passed yet.

Furthermore, In her instant application, the Officer has submitted that she has cleared Delhi Judicial Services (Main) Examination 2019, the result of which was declared on 13.01.2020 vide public notification of Hon'ble Delhi High Court. Now, the Officer has requested for 'No Objection Certificate' for appearing in the interview of Delhi Judicial Services Examination 2019. As the officer has cleared Mains

examination of Delhi Judicial Service Examination 2019 and has been qualified for the interview of the same. Therefore, she may be issued 'No Objection Certificate' to appear in the interview of Delhi Judicial Service Examination-2019, if the Court so desires.

May, therefore, if approved, the instant matter kindly be laid before Hon'ble Ms. Justice Naheed Ara Moonis, Administrative Judge, Auraiya Judgeship for Her Lordship's kind perusal & if Her Lordship approves 'No Objection Certificate' be issued, offline, in duplicate, under the signature of Registrar (Judicial) Budget in favour of Smt. Surabhi Shree Gupta, Civil Judge (Jr. Div.), Auraiya to appear in the interview of Delhi Judicial Service Examination-2019, as requested?
