May kindly see the online application, received from Sushri Shaleen Mishra, Addl. Civil Judge (Jr. Div.), Gonda by which he has requested for grant of permission to visit Mauritius from 01.06.2020 to 10.06.2020 alongwith her parents.

In her letter, Sushri Shaleen has stated that she wishes to visit Mauritius with her parents during summer vacation June 2020 i.e. from 01.06.2020 to 10.06.2020. She has also enclosed copy of her passport as attachment. She has also submitted following details/ declaration which are as follows:-

1. By her visit to Mauritius in the month of June 2020, no dilemma is likely to create before Government of India or U.P. due to his visit abroad.
2. Such type of request for abroad visit was not refused to her earlier.
3. She has visited Nepal before joining the service in 2011 with her family members.
4. The estimated expenditure for her visit will be around 65,000/- to 70,000/-per person and the same will be paid by her from the credit card linked to her salary account no. 33648984164.

She has, therefore, requested to place his application for grant of permission to visit Mauritius alongwith her parents from 01.06.2020 to 10.06.2020.

In this connection, it is submitted that as per reports, no departmental/ vigilance enquiry is pending against Sushri Shaleen Mishra. Permission to visit foreign country is considered vide G.O no. 1/3/98/-Ka Prasko./1999 dated 14.06.1999 and this Court's Circular letter no. 16/ IVf-101/Admin (A) dated 27.05.2017. As per the G.O. and relevant C.L. of the Court, the officer has furnished details of her

visit. It is pertinent to mention here that as the days of her Mauritius visit are falling in the recess period and its upto the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Gonda to grant her permission to visit Mauritius in the month of June 2020 i.e. from 01.06.2020 to 10.06.2020 seeing the Court's C.L. dated 27.05.2017, approving guidelines that *abroad tour by any officer shall not be availed of during working days of the Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/herself, spouse or dependent, or in special circumstances and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacations. In these eventualities the Judicial Officers shall seek permission before applying for VISA.* In the instant case, the tour of the officer appears to be a personal trip, falling in her recess period, if His Lordships deem fit and proper, her request may be considered. It is also submitted that vide the aforesaid C.L. date 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice.

May, therefore, if approved, the file may be laid before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Gonda Judgeship for kind perusal and orders and if His Lordship approves, Sushri Shaleen Mishra, Addl. Civil Judge (Jr. Div.), Gonda may be granted permission to visit Mauritius in the month of June 2020 i.e. from 01.06.2020 to 10.06.2020 alongwith her parents, as requested, subject to the conditions that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad and also subject to further approval by Hon'ble The Chief Justice, as per requirement of Court's
