Sri Avinash Kumar Mishra, aforesaid, had earlier online requested on 29.01.2020 for inclusion of LL.M qualification in his service-records and uploaded self attested copies of mark-sheet and degree of LL.M. Thereafter, objection raised in instant matter by Admin-A1 for upload attested copies (not self-attested) of mark-sheets(all semesters) as well as degree of LL.M. Now, he has submitted attested copies of mark-sheets(all semesters) and degree of LL.M on 01.02.2020 (online attached on 01.02.2020).

In this context, it is submitted that Sri Avinash Kumar Mishra, aforesaid, joined U.P.Judicial Services on 10.07.2018 Civil Addl. Judge (Junior as Ballia. Besides, as apparent from submitted attested copies of mark-sheets(all semesters) as well as degree of LL.M(online attached on 01.02.2020), Sri Avinash Kumar Mishra, completed LL.M course in year 2017 and was subsequently awarded Degree from University of Delhi on 19.11.2018. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Avinash Kumar Mishra, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 28.01.2020(online attached on 29.01.2020)

of Sri Avinash Kumar Mishra, Addl. Civil Judge (Junior Div.), Ballia, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Ballia, for kind perusal and order to the effect that copy of aforesaid letter dated 28.01.2020(online attached on 29.01.2020) along with attested copies of mark-sheets(all semesters) and degree of LL.M(online attached on 01.02.2020) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Komal Srivastava, Addl. Civil Judge (Junior Div.), Varanasi, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
