May kindly see letter dated 07.02.2020 alongwith attested copy of degree of Ph.D (**online attached on 07.02.2020**) of Sri Devendra Singh Fauzdar, Secretary, D.L.S.A., Budaun, regarding inclusion of degree of Doctor of Philosophy (Ph.D.) in Law and add prefixing word 'Doctor' before name in his service records.

Sri Devendra Singh Fauzdar, aforesaid, had earlier permitted to complete his research (in Law) for topic on “Medical Negligence attributed to Unethical Practice: A socio legal study pertaining to the liability of medical practitioners and establishments in India” vide Court's order dated 13.10.2015 and the same has communicated vide court's endorsement no. 13956/IV/4121/Admin.(A) dated 14.10.2015(**offline mode**). Sri Devendra Singh Fauzdar, aforesaid, has further requested vide his letter dated 02.02.2019(**offline mode**) for adding “Dr.” as prefix before his name and submitted self-attested copy of Notification pertaining to award of Ph.D degree. Thereafter, he has been requested vide Court's letter no. 6235/IV-4121/Admin.(A) dated 14.05.2019(**offline mode**) for submission of attested copy Ph.D degree alongwith other relevant credentials, if any, whereas, he has submitted self attested copy of Ph.D degree on 31.01.2020(**through online**) without accompanied pray for inclusion of degree of Doctor of Philosophy (Ph.D.) in Law and add prefixing word 'Doctor' before his name in his service records . Thereafter, objection raised in instant matter by Admin-A1 for upload attested copy (not self-attested) degree of Ph.D accompanied with request application for inclusion of degree of Doctor of Philosophy (Ph.D.) in Law and add prefixing word 'Doctor' before his name in his service records. Now, he has uploaded attested copy of degree of Ph.D accompanied with request application dated 07.02.2020(**online attached on**

07.02.2020)for inclusion of degree of Doctor of Philosophy (Ph.D.) in Law and add prefixing word 'Doctor' before his name in his service records.

In this context, it is submitted that Sri Devendra Singh Fauzdar, aforesaid, joined U.P.Judicial Services on 18.02.2015 as Addl. Civil Judge (Junior Div.), Farrukhabad. Besides, as apparent from submitted attested copy of degree of Ph.D(**online attached on 07.02.2020**), Sri Devendra Singh Fauzdar, awarded the degree of Doctor of Philosophy (Ph.D) in Law in year 2018 from Aligarh Muslim University, Aligarh and issued on 11.01.2020. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included and add prefixing word 'Doctor' before name in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of Ph.D degree, may be included and add prefixing word 'Doctor' before name in service records of Sri Devendra Singh Fauzdar, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 07.02.2020(**online attached on 07.02.2020**) of Sri Devendra Singh Fauzdar, Secretary, D.L.S.A., Budaun, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Budaun, for kind perusal and order to the effect that copy of aforesaid letter dated 07.02.2020 along with attested copy of Ph.D degree (**online attached on 07.02.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Devendra Singh Fauzdar, Secretary, D.L.S.A., Budaun, may be sent to the Joint Secretary,
