May kindly see letter dated 06.02.2020 alongwith attested copies of mark-sheet and degree of LL.M (**online attached on 07.02.2020**) of Sushri Shambhavi, Judicial Magistrate, Ghazipur, requesting for inclusion of LL.M qualification in her service-records.

Sushri Shambhavi, aforesaid, had earlier requested for grant of Three Advance Increments vide District Judge, Ghazipur endorsement no. 1296/XV dated 21.08.2019 (**offline mode**). Thereafter, she has been requested vide Court's endorsement no. 15030/IV-4497/Admin.(A) dated 18.10.2019(**offline mode**) for submission of attested copies of mark-sheets and LL.M degree to this Court and she may also be requested to clarify the actual date of result declaration of final year vide which she had successfully completed LL.M course. Now, she has submitted letter dated 06.02.2020 alongwith attested copies of mark-sheet and LL.M degree accompanied with pray for inclusion of LL.M qualification in her service-records(**online attached on 07.02.2020**) and also clarified that the actual date of result declaration of final year of her LL.M course is 3rd October, 2018.

In this context, it is submitted that Sushri Shambhavi, aforesaid, joined U.P.Judicial Services on 29.06.2018 as Addl. Civil Judge (Junior Div.), Ghazipur. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M(**online attached on 07.02.2020**), Sushri Shambhavi, completed LL.M course in year 2018 and was subsequently awarded Degree from The Global Open University, Nagaland on 27.05.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Shambhavi, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 06.02.2020(**online attached on 07.02.2020**) of Sushri Shambhavi, Judicial Magistrate, Ghazipur, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Abhinava Upadhyaya, Administrative Judge, Ghazipur, for kind perusal and order to the effect that copy of aforesaid letter dated 06.02.2020 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 07.02.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Shambhavi, Judicial Magistrate, Ghazipur, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
