May kindly see letter dated 12.02.2020 alongwith attested copies of mark-sheets(both years) and degree of LL.M **(online attached on 12.02.2020)** of Smt. Asha Rani Singh, Spl. Judge(E.C.Act), Sultanpur, requesting for inclusion of LL.M qualification in her service-records.

Smt. Asha Rani Singh, aforesaid, had earlier requested for grant of Three Advance Increments vide District Judge, Sultanpur endorsement no. 2596/I dated 03.08.2018 **(offline mode)**. Thereafter, she has been requested vide Court's endorsement no. 1859/IV-3351/Admin.(A1) dated 04.02.2020**(offline mode)** for submission of attested copies of mark-sheets and LL.M degree to this Court either by post or online through eServicesJO portal. Now, she has submitted vide letter dated 12.02.2020 alongwith attested copies of mark-sheets(both years) and LL.M degree accompanied with pray for inclusion of LL.M qualification in her service-records**(online attached on 12.02.2020)**.

In this context, it is submitted that Smt. Asha Rani Singh, aforesaid, joined U.P.Judicial Services on 17.06.2006 as Addl. Civil Judge (Junior Div.), Hathras. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M**(online attached on 12.02.2020)**, Smt. Asha Rani Singh, completed LL.M course in year 1996 and was subsequently awarded Degree from Chaudhary Charan Singh University, Meerut on 20.05.1997. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Smt. Asha Rani Singh, aforesaid with the permission of Government of

U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 12.02.2020(**online attached on 12.02.2020**) of Smt. Asha Rani Singh, Spl. Judge(E.C.Act), Sultanpur, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Sultanpur, for kind perusal and order to the effect that copy of aforesaid letter dated 12.02.2020 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 12.02.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Smt. Asha Rani Singh, Spl. Judge(E.C.Act), Sultanpur, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
