

**Ld. Registrar(J)(Budget)**

May kindly see online request dated 19.02.2020 accompanied with application dated 24.02.20 and other essential documents(submitted as attachments on 20.02.20, 24.02.20 & 26.02.20) of Sri Shiva Kumar Singh, Additional District Judge(POCSO), Shravasti at Bhinga regarding sanction of final withdrawal of Rs.20,00,000/- to good self out of the total amount standing to his credit in G.P.F Account No. LJU-22525, to mete out expenses due to arise in upcoming marriage of his daughter, Ms. Shreya Singh.

Vide self-attested copy of Lagna patrika dated 24.02.20, Sri Shiva Kumar Singh has informed that the marriage of his daughter Ms. Shreya Singh is due to be solemnized on 11.12.2020 with Mr. Bharat Bhushan S/o Sri Ashok Kumar. Thus, he has requested for sanction of Rs.20,00,000/- from his GPF account.

In this connection it is submitted that the aforesaid request of Sri Shiva Kumar Singh may be considered under provision of Rule 16(1)(A)(b) of G.P.Fund(U.P) Rules, 1985, which is as follows :

Rule 16(1)(A) : After the completion of twenty years of service (including period of suspension followed by reinstatement and other broken periods of service, if any) of a subscriber or within 10 years before the date of his retirement on superannuation, whichever is earlier, from the amount standing to his credit in his GPF Account for one or more of the following purposes, namely:

(a) .....

(b) meeting the expenditure in connection with the marriage of the subscriber's son or daughter, and any other relation actually dependent on him.

(c) .....

Sri Shiva Kumar Singh has also enclosed self-attested photocopy of last four F.Ys(including current F.Y.) GPF pass-book statements and certificate dated 19.02.20, of the District Judge, Shravasti as the evidence of total amount standing to his credit in his GPF Account No. LJU-22525. As per GPF pass-book statement for the F.Y 2018-19 & 2019-20 and certificate of the District Judge, Shravasti, a total amount of Rs.44,89,241/- stands to his credit in his GPF Account out of which final withdrawal of Rs.20,00,000/- can be sanctioned.

The District Judge, Shravasti has further certified vide certificate dated 19.02.20 that till date Sri Shiva Kumar Singh has not taken any temporary advance or final withdrawal from his GPF A/c. He had joined U.P.Judicial services on 29.03.1996 and is due to retire on 31.03.2028.

He has put in more than twenty years of his age in this service and currently his Basic Pay is Rs.63,070/-.

Final Withdrawal of Rs.20,00,000/- may be sanctioned to Sri Shiva Kumar Singh from his GPF Account No. LJU-22525, for meeting out the expenses due to arise in upcoming marriage of his daughter, as a special case, in terms of sub rule 16(1)(A)(b) read with 17(1)(a), which allows sanction of withdrawal upto 3/4<sup>th</sup> of the balance at the credit of officer in the Fund, of G.P.Fund(U.P) Rules, 1985, subject to the following conditions :

1. That the amount shall not be withdrawn unless it is actually required for the purpose and it shall not be utilized for any other purpose.
2. That a utilization certificate shall be furnished to the Court within the time allowed in rule.
3. That the amount sanctioned for marriage shall be utilized within 3 months from the date of withdrawal.
4. That the Treasury Officer, Shravasti as well as the D.D.O, District Court, Shravasti shall ensure to mention the amount of Final Withdrawal in the withdrawal column of GPF pass-book of Sri Shiva Kumar Singh, without delay.
5. That as per undertaking dated 19.02.20, issued by Sri Shiva Kumar Singh under his own signature, any excess payment made in his favour shall be returned by him immediately to the concerned authority/account.

In the view of above submitted facts and information, if approved by Learned Registrar(Judicial)(Budget), instant request of Sri Shiva Kumar Singh, aforesaid may kindly be placed before Hon'ble Mr. Justice Om Prakash-VII, for His Lordship's kind perusal and order to the effect that an amount of Rs.20,00,000/-(Twenty Lacs) only as final withdrawal may be sanctioned to Sri Shiva Kumar Singh, Additional District Judge(POCSO), Shravasti at Bhinga against his GPF Account No. LJU-22525, for meeting out the expenses relevant with marriage of his daughter, as a special case, in terms of sub rule 16(1)(A)(b) read with 17(1)

(a) of G.P.Fund(U.P) Rules, 1985, subject to the conditions mentioned above ?
