

**Joint Registrar(J)(Budget)**

May kindly see the letter uploaded on date 15.07.2020 along with attested copies of mark-sheets (all semesters) and degree of LL.M (online attached on 15.07.2020 at SL No. 04 & 05) of Sri Vipul Kumar Yadav, Addl. Civil Judge (Jr. Div.) Azamgarh, requesting for inclusion of LL.M qualification in his service-records.

Sri Vipul Kumar Yadav, aforesaid, had earlier requested for inclusion of LL.M. Qualification in his service records on 22.02.2020 uploading unattested copies of marksheets and Degree of LL.M. Qualification (**Online attached on 22.02.2020 at SL No. 01 & 02**). Thereafter he was requested vide online office note dated 09.06.2020 to upload attested copies of mark sheets (all semesters/years) and Degree of LL.M. Qualification for further necessary action. Now he has uploaded attested copies of mark-sheets (all semesters) and LL.M degree on 15.07.2020 (**online attached on 15.07.2020 at SL No. 04 & 05**) along with prayer for inclusion of LL.M qualification in his service-records (**online attached on 15.07.2020 at SL No. 03**).

In this context, it is submitted that Sri Vipul Kumar Yadav, aforesaid, joined U.P. Judicial Services on 15.11.2019 as Addl. Civil Judge (Junior Div.), Azamgarh. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 15.07.2020 at SL No. 04 & 05**), Sri Vipul Kumar Yadav, completed LL.M course in year 2017 and was subsequently awarded Degree from Noida International University, Noida on 06.03.2018. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Vipul Kumar Yadav, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter uploaded on date 15.07.2020 at SL No. 03 of Sri Vipul Kumar Yadav, Addl. Civil Judge (Jr. Div.) Azamgarh, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Azamgarh, for kind perusal and order to the effect that copy of aforesaid letter uploaded on 15.07.2020 at SL No. 03 along with attested copies of mark-

sheets and degree of LL.M. (**online attached on 15.07.2020 at SL No. 04 & 05**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Vipul Kumar Yadav, Addl. Civil Judge (Jr. Div.) Azamgarh may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
