May kindly see the online office note dated 30.11.2019 regarding grant of permission to purchase plot no. NP-74, measuring 247.25 sq. m., Ganga Nagar, Meerut as submitted by Smt. Saloni Rastogi, Additional Civil Judge (Sr. Div.), Muzaffarnagar.

Hon'ble Mr. Justice Pradeep Kumar Srivastava, Nominated Judge for disposal of the matters of Judicial Officers, has been pleased to order on the forwarding note to J. R. (Budget) regarding the matter:-

***“Office may be directed to clarify the discrepancy arises between the amount proposed by the office i.e. Rs. 35,00,000/- for approval of His Lordship and amount sanctioned by the Bank i.e. Rs. 31,50,000/-.”***

Accordingly, as per the order of His Lordship, it is most humbly submitted that as stated by the officer the loan proposed to be taken was of Rs. 35,00,000/- regarding purchase of the abovementioned plot. At first, no loan paper & copy of passbook has been submitted by the officer. Thereafter, an objection was raised by the office to submit offer letter of bank & copy of passbook regarding the same. Thereafter, the loan paper of Rs. 31,50,000/- has been submitted by the officer, upon which office note dated 30.11.2019 was submitted online. However, inadvertently, in the same, the proposed loan amount was shown as Rs. 35,00,000/-, as earlier stated by the officer. Now, it is found that the actual loan amount approved is Rs. 31,50,000/- only.

Moreover, it is also to submit that rest of the amounts regarding purchase of the said plot other than the loan amount will be paid both by the officer & her spouse who have sufficient amounts in their A/cs i.e. in the officer's A/c no. 38454732764 there is a balance of Rs. 5,51,269/- & in her spouse's A/c no. 50457620273, there is a balance of Rs. 6,46,888/-. As such, even if the officer get loan of Rs. 31,50,000/-, she would have sufficient sum to bear the expenses for purchase of the property from her S.B. A/c and her spouse's S.B. A/c for the rest payment.

Under the facts and circumstances, may, if approved, the file again be laid before Hon'ble Mr. Justice Pradeep Kumar Srivastava for His Lordship kind perusal/ information and further orders in the matter of grant of permission to the officer, as already proposed through earlier office note dated 30.11.2019?
