May kindly see letter dated 02.09.2019 alongwith attested copies of mark-sheets(all semesters) and degree of LL.M **(online attached on 22.06.2020)** of Smt. Bhavya Tiwari, Additional Civil Judge (Sr. Div.), Lucknow, requesting for inclusion of LL.M qualification in her service-records.

Smt. Bhavya Tiwari, aforesaid, had earlier requested for grant of permission for complete the LL.M IVth Semester (Final) examination 2014-15 of Delhi University, Delhi. Thereafter, this Court has granted permission to Smt. Bhavya Tiwari, for her appearance in LL.M IVth Semester (Final) examination 2014-15 on 04.05.2015 and the same is communicated to her vide Court endorsement no. 6716/IV-4130/Admin(A-4)/ Dated 06.05.2015. Now, she has submitted vide letter dated 02.09.2019 alongwith attested copies of mark-sheets(all semesters) and LL.M degree accompanied with pray for inclusion of LL.M qualification in her service-records**(online attached on 22.06.2020)**.

In this context, it is submitted that Smt. Bhavya Tiwari, aforesaid, joined U.P.Judicial Services on 21.03.2015 as Addl. Civil Judge (Junior Div.), Jhansi. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M**(online attached on 22.06.2020)**, Smt. Bhavya Tiwari, completed LL.M course in year 2015 and was subsequently awarded Degree from University of Delhi, Delhi on 19.11.2016. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Smt. Bhavya Tiwari, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid

letter dated 02.09.2019(**online attached on 22.06.2020**) of Smt. Bhavya Tiwari, Additional Civil Judge (Sr. Div.), Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Ritu Raj Awasthi, Administrative Judge, Lucknow, for kind perusal and order to the effect that copy of aforesaid letter dated 02.09.2019 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 22.06.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Smt. Bhavya Tiwari, Additional Civil Judge (Sr. Div.), Lucknow, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
