May kindly see letter dated 09.07.2020 (**Online attached on 09.07.2020**) alongwith attested copies of mark-sheets (both semesters) and degree of LL.M (**online attached on 21.07.2020 at SL No. 05 & 06**) of Sri Abhinav Devesh Shukla, Civil Judge (Jr. Div.), Lucknow, requesting for inclusion of LL.M qualification in his service-records.

Sri Abhinav Devesh Shukla, aforesaid, had earlier uploaded unattested copy of Marksheet and LL.M. Degree online on 26.06.2020 (**online attached at SL No. 01 & 02**) and also online requested for inclusion of LL.M. Qualification in his service records on 09.07.2020. Thereafter, He was requested vide online office note dated 10.07.2020 for submission of attested copies of mark-sheets (all semesters) and LL.M degree to this Court for further necessary action in instant matter. Now, He has uploaded attested copies of mark-sheets(all semesters) and LL.M degree accompanied with inclusion request of LL.M. Qualification in his service records (**online attached on 21.07.2020 at SL No. 05 & 06**).

In this context, it is submitted that Sri Abhinav Devesh Shukla, aforesaid, joined U.P.Judicial Services on 16.11.2019 as Addl. Civil Judge (Junior Div.), Lucknow. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 21.07.2020 at SL No. 05 & 06**), Sri Abhinav Devesh Shukla, completed LL.M course in year 2019 and was subsequently awarded Degree from Amity University, Noida on 09.11.2019. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Abhinav Devesh Shukla, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 09.07.2020 (**Online attached on 09.07.2020**) of Sri Abhinav Devesh Shukla, Civil Judge (Jr. Div.), Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Vivek Agarwal, Administrative Judge, Lucknow, for kind perusal and order to the effect that copy of aforesaid letter dated 09.07.2020 along with attested copies of mark-sheets

and degree of LL.M. (online attached on 21.07.2020 at SL No. 05 & 06) as well as attested copy of form of U.P.Nyayik Sewa of Sri Abhinav Devesh Shukla, Civil Judge (Jr. Div.), Lucknow, , may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
