May Kindly see the online application, of Sushri Anchal Rana, Addl. Civil Judge (Jr. Div.), Muzaffarnagar in which she has requested for grant of permission to appear in Delhi Judicial Services (Main) Examination 2019.

In her application, Sushri Rana has stated that she was granted permission by Hon'ble High Court of Judicature at Allahabad to appear in the Delhi Judicial Service (Preliminary examination) 2019 vide letter bearing endorsement no. 13604 / IV-4509 / Admin(A-4) dated 19.09.2019, pursuant to which she appeared in the preliminary examination and now got shortlisted for the Delhi Judicial Services (Mains) examination 2019 vide public notification of the Hon'ble High Court of Delhi dated 02.10.2019 Mains examination held on 12.10.2019 and 13.10.2019. She has, therefore, requested to the Hon'ble Court to grant her permission for appearing in the Delhi Judicial Services (Main) Examination 2019. The aforesaid online application was received through e-services portal on 14.10.2019 after the Durga Puja holidays i.e. after the date of the examination. Therefore, she was asked to intimate to the Court as to whether she had appeared in the Mains examination of the aforesaid examination, in anticipation of Court's permission, and if yes, what about its result, so that further necessary action may be taken in the matter.

In reply, Sushri Rana has stated that she had appeared in the Delhi Judicial Service Examination (Mains) 2019 in anticipation of Hon'ble High Court's permission and have cleared the aforesaid examination the result of which was declared on 13.01.2020.

In this connection, it is submitted that the officer has joined the U.P. Nyayik Sewa on 18.06.2018. Earlier, vide this Court's letter dated 19.09.2019 of Hon'ble the Administrative Judge, Muzaffarnagar, she had been accorded permission to appear in the preliminary exam of Delhi Judicial Services Examination, 2019. Now, the Officer has requested for grant of permission to appear in Delhi Judicial Services (Main) Examination 2019. As the said examination has already been conducted and the officer has appeared in that examination in anticipation of the Court' permission, therefore, it appears to be proper to grant her ex-post facto permission to appear in the Mains examination of Delhi Judicial Service Examination, 2019, in order to regularize the matter.

Undre the facts and details mentioned above, may, therefore, if approved, the instant matter be laid before Hon'ble Mr. Justice Ramesh Sinha, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders to the effect that ex-post facto permission be granted to Sushri Anchal Rana, Addl. Civil Judge (Jr. Div.), Muzaffarnagar for her appearance in the Mains examination

of Delhi Judicial Service Examination, 2019 already held on 12.10.2019 and 13.10.2019, as required and requested by her?
