

## Registrar (J) (Budget)

May kindly see the online application of Sri Vinod Kumar Chaurasia, Additional District & Sessions Judge, Ghaziabad for grant of permission to sell his old Maruti Celerio VXI car.

In his letter, Sri Chaurasia has stated that he has purchased a new Tata Harrier XZA+2.0L Kryotee BSVL on 25.06.2020 (information for the same has already been intimated). It is further prayed that he has one old Maruti Celerio VXI car (2017 Model), bearing reg. no. UP 14 DL 1167 which he had purchased in November 2017 i.e. prior to the joining of this service. Copy of Registration Certificate & invoice of his Maruti Celerio car has been submitted by the officer as attachment. He has joined the present service on 01.08.2019. Now, as he has purchased the aforementioned car recently and it is not possible for him to maintain & take care of other expenses of his old Maruti Celerio VXI car, thus, he has planned to sell off his old car to Sri Arun Kumar Srivastava (Retired as DJ & Chairperson of District Consumer Forum (U.P.), R/o C-626, Gaur Homes, Govindpuram, Ghaziabad, 201013. for Rs. 3,50,000/-. The proposed buyer of the above car is not related to him in any way. No case against the proposed buyer of the above car is pending in his court, nor he has decided any case of the proposed buyer of the above car. He has, therefore, requested that the Hon'ble Court may be pleased for grant of permission for sale of car to the purchaser.

In this connection, it is submitted that the car has been purchased by the officer in the year 2017 i.e. prior to the joining of this service. The relevant Rule 24(2) of the U.P. Government Servant's Conduct Rules-1956, applicable in this case, is reproduced as below: -

*“A Government servant who enters into any such transaction concerning any movable property exceeding in value the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority.*

*Provided that no Government servant shall enter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."*

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Om Prakash-VII for His Lordship's kind perusal and if His Lordship's approves, Sri Vinod Kumar Chaurasia, Additional District & Sessions Judge, Ghaziabad be granted permission to sell his Maruti Celerio VXi car bearing reg. no. UP14 DL 1167, to Sri Arun Kumar Srivastava, R/o C-626, Gaur Homes, Govindpuram, Ghaziabad, 201013. for Rs. 3,50,000/-, as requested, subject to the condition that the relevant papers in connection with the sale transaction shall be furnished immediately on completion of the transaction?
