May Kindly see the online application of Sushri Sonali Mishra, Addl. Civil Judge (Jr. Div.), Lucknow by which she has requested for issuance of 'No Objection Certificate' for appearing in the interview of Uttar Pradesh Combined State/ Upper Subordinate Services Examination 2018 conducted by Uttar Pradesh Public Service Commission.

In her application, Sushri Mishra has stated that she had appeared in UPPCS mains examination (Roll no 508367) held between 18.10.2019 to 20.10.2019; before her joining in the Uttar Pradesh Judicial services and have cleared Mains Examination via notification no. - 35/2/E-3/2018-19 dated 23-06-2020 and now she has received an interview call to be held on 31-07-2020 as per the notice of Uttar Pradesh Public service Commission no 35/2/E-3/2018-19. Therefore, she may be issued 'No Objection Certificate' to appear in the interview of Uttar Pradesh Combined State/ Upper Subordinate Services Examination 2018, scheduled on 31.07.2020, if the Court so desires.
