

### Registrar(J) (Budget)

May kindly see the online application of Sri Sunandan Goyal, Nyayadhikari, Gram Nyayalaya, Bah-Agra regarding grant of permission to do/pursue LL.M. Course through correspondence from Kurukshetra University.

In his application, Sri Goyal has stated that he wishes to pursue LL.M. (2 year) Course through correspondence from Kurukshetra University, Kurukshetra, Haryana for the academic session 2020-2022. He has also stated that he can pursue the Course without attending day to day classes and no judicial work would get hampered from his studies. He has further stated that no study leave would be required to him for this Course. He has also enclosed prospectus and syllabus of his LL.M. Course as attachment. He has, therefore, requested for grant of permission to pursue LL.M. Course through correspondence from the aforesaid University.

In this connection, it is stated that Sri Goyal has joined the U.P. Nyayik Sewa on 16.11.2019. There is circular letter dated 4.11.11, which provides that if any Judicial Officer during the course of his Service, requests to pursue higher studies, he has to apply for grant of 'Study Leave' as per rules which will be subject to the discretion of Hon'ble the Chief Justice. In the instant case, the officer has stated that he would not take study leave for the said LL.M. Course, his request appears to be considerable. However acceptance of his request is on the discretion of the Court. It is also submitted that a Judicial Officer can be accorded permission to attend academic classes and specialized higher studies in terms of G.O. No.24/1066-Appointment (B) dated 21.08.1967, subject to the following conditions:-

1. *Government work should not suffer in any way.*
2. *The academic classes, if any are held outside office hours.*
3. *No preferential treatment will be given in the matter of leave postings and transfer.*

4. *The permission can be withdrawn without notice if; it is found at any time that the government servant neglects his normal work or that public work suffers, in any way.*

May, therefore, if approved, the instant matter may be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and if His Lordship approves :-

(a) Sri Sunandan Goyal, Nyayadhikari, Gram Nyayalaya, Bah-Agra may be granted permission to do/ pursue the LL.M. Course through correspondence from Kurukshetra University, Kurukshetra, Haryana, for the academic session from 2020- 2022 with exemption of the requirement to take study leave for the same and without entering into the fact whether the University is recognised by UGC or not as well as without reserving any future claim of the officer regarding his qualification if the University is not recognised and also subject to the conditions mentioned above.

Or

(b) to pass any other order which His Lordship deem fit and proper .
