May kindly see letter dated 14.07.2020 along with attested copy of mark-sheet (all semesters/consolidated) and degree of LL.M (online attached on 14.07.2020) of Sri Utkarsh Yadav, Addl. Distt. & Sessions Judge, Bareilly, requesting for inclusion of LL.M qualification in his service-records.

Sri Utkarsh Yadav, aforesaid, had earlier prayed for addition of LL.M. Qualification in his service records and subsequent grant of Three Advance Increments vide Hon'ble District Judge, Bareilly on 14.07.2020 (online mode). (Documents attached online on 14.07.2020).

In this context, it is submitted that Sri Utkarsh Yadav, aforesaid, joined U.P. Higher Judicial Services on 31.08.2019 as Addl. Distt. & Sessions Judge, Bareilly. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M(online attached on 14.07.2020), Sri Utkarsh Yadav, completed LL.M course in year 2011 and was subsequently awarded Degree from Indian Law Institute, New Delhi on 21.02.2012. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P. UPHJS, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers of UP H.J.S. is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Utkarsh Yadav, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 14.07.2020(online attached on 14.07.2020) of Sri Utkarsh Yadav, Addl. Distt. & Sessions Judge, Bareilly, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Bareilly, for kind perusal and order to the effect that copy of aforesaid letter dated 14.07.2020 along with attested copies of mark-sheet and degree of LL.M. (online attached on 14.07.2020) as well as attested copy of form of U.P. H.J.S. of Sri Utkarsh Yadav, Addl. Distt. & Sessions Judge, Bareilly, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
