May kindly see letter dated 18.07.2020 alongwith attested copies of mark-sheets (all semesters) and degree of LL.M (**online attached on 18.07.2020**) of Sri Prashant Singh, Civil Judge (Junior Div.), Sitapur, requesting for inclusion of LL.M qualification in his service-records.

Sri Prashant Singh, aforesaid, had earlier requested for inclusion of LL.M qualification in his service-records vide District Judge, Sitapur on 18.07.2020 (**online mode**). He has also uploaded mark-sheets (all semesters) and LL.M. Degree accompanied with prayer for inclusion of subject qualification in his service-records (**online attached on 18.07.2020**).

In this context, it is submitted that Sri Prashant Singh, aforesaid, joined U.P.Judicial Services on 16.12.2019 as Civil Judge (Junior Div.), Sitapur. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M (**online attached on 18.07.2020**), Sri Prashant Singh, completed LL.M course in year 2019 and was subsequently awarded Degree from Lucknow University, Lucknow on 15.10.2019. Nevertheless, relevant detail about course completion is not mentioned in his application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sri Prashant Singh, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 18.07.2020(**online attached on 18.07.2020**) of Sri Prashant Singh , Civil Judge (Junior Div.), Sitapur may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Pankaj Naqvi, Administrative Judge, Sitapur, for kind perusal and order to the effect that copy of aforesaid letter dated 18.07.2020 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 18.07.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Sri Prashant Singh , Civil Judge (Junior Div.), Sitapur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
