May kindly see letter dated 24.07.2020 alongwith attested copies of mark-sheets(all semesters) and degree of LL.M (**online attached on 24.07.2020**) of Sushri Avantika Prabhakar, Addl. Civil Judge (Jr. Div.) Mirzapur, requesting for inclusion of LL.M qualification in her service-records.

Sushri Avantika Prabhakar, aforesaid, had earlier requested for grant of Three Advance Increments vide District Judge, Mirzapur endorsement no. 1759/I/Mirzapur dated 16.07.2019 (**offline mode**). Thereafter, she has been requested vide Court's endorsement no. 5099/IV-4662/Admin.(A1) dated 19.06.2020(**offline mode**) for submission of attested copies of mark-sheets and LL.M degree accompanied with prayer for inclusion to this Court either by post or online through eServicesJO portal. Now, she has uploaded attested copies of mark-sheets(all semesters) and LL.M degree accompanied with prayer for inclusion of LL.M qualification in her service-records vide letter dated 24.07.2020 (**online attached on 24.07.2020**).

In this context, it is submitted that Sushri Avantika Prabhakar, aforesaid, joined U.P.Judicial Services on 28.09.2018 as Addl. Civil Judge (Junior Div.), Mirzapur. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M(**online attached on 24.07.2020**), Sushri Avantika Prabhakar, completed LL.M course in year 2018 and was subsequently awarded Degree from Babasaheb Bhimrao Ambedkar University, Lucknow on 11.11.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Avantika Prabhakar, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 24.07.2020(**online attached on 24.07.2020**) of Sushri Avantika Prabhakar, Addl. Civil Judge (Jr. Div.) Mirzapur, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Mirzapur, for kind perusal and order to the effect that copy of aforesaid letter dated 24.07.2020 along with attested copies of mark-sheets and degree of LL.M. (**online attached on 24.07.2020**) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Avantika Prabhakar, Addl. Civil Judge (Jr. Div.) Mirzapur, may be sent to the Joint Secretary, Appointment
