May kindly see the online application of Sushri Pragya Parashar, Additional Civil Judge (Jr. Div.), Firozabad regarding information about transfer of Maruti Wagon R car from her father's name into her name.

In her application, Sushri Pragya has stated that her father Dr. Amar Nath Parashar who is retired as a lecturer from B.R. Inter College, Fatehpur Sikri (Agra) had purchased a Wagon R car having registered plate no. UP80EU3111. As now, he is retired & relaxing at home, he did not have any need of the use of above mentioned car. On the other hand, as he thought it is needful for her daily use, he gifted the abovementioned car to her & for the mutual happiness of each other, she accepted his gift & felt obliged. (Copy of 'Consent Letter' of her father can be seen as attachment). Moreover, it is also pertinent to mention here that on 01.02.2020, her father (Dr. Amar Nath Parashar) has officially transferred the abovementioned car in her name (Copy of RC of her father as well as transferred RC in the name of the officer can be seen as attachment). The officer has submitted information for kind perusal of Hon'ble Court.

In this connection, it is submitted that the aforementioned car appears to have been purchased by her father out of his salary savings. (copy of 'Delivery Challan' & copy of his passbook can be seen as attachment). It is further submitted that the relevant Rule 11 of U.P. Government Servant's conduct Rule-1956 relating to gift and, Rule 24 (2) of U.P. Government Servant's conduct Rule-1956 relating to transfer of movable property runs as under: -

11. Gifts:-*A government servant shall not without previous approval of Government :-*

(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or

(b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.

24 (2). *"A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for*

one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority.”

In view of the above, the information so submitted by the officer is likely to be acceptable, as the car has been gifted by the father of the officer to her daughter, which is the closest blood relative. There appears to be nothing objectionable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Om Prakash-VII, Nominated Judge for disposal of the matters of Judicial Officers, of information/ permission of sale/purchase of movable/immovable property or gift etc., for the District Ferozabad, for His Lordship's kind perusal and information under Rule 24(2) and Rule (11) of U.P. Government Servant's Conduct Rules, 1956?
