May kindly see letter dated **11.08.2020** alongwith attested copies of mark-sheets (all semesters) and degree of LL.M (**online attached on 07.01.2021**) of Sushri Bushra Noor, Metropolitan Magistrate, Kanpur Nagar, requesting for inclusion of LL.M qualification in her service-records.

Sushri Bushra Noor, aforesaid, had earlier uploaded self attested copies of marksheets (all semesters) and degree of LL.M (**online attached on 11.08.2020**). Thereafter, she was requested vide court's online note dated 04.01.2021 to upload attested copies of mark-sheets (all semesters/ years) and Degree of LL.M. Now, she has uploaded attested copies of mark-sheets(all semesters) and LL.M degree accompanied with pray for inclusion of LL.M qualification in her service-records(**online attached on 07.01.2021**).

In this context, it is submitted that Sushri Bushra Noor, aforesaid, joined U.P. Judicial Services on 16.11.2019 as Metropolitan Magistrate, Kanpur Nagar. Besides, as apparent from submitted attested copies of mark-sheets and degree of LL.M(**online attached on 07.01.2021**), Sushri Bushra Noor, completed LL.M course in year 2019 and was subsequently awarded Degree from Lucknow University, Lucknow on 15.10.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Bushra Noor, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 11.08.2020(**online attached on 11.08.2020**) of Sushri Bushra Noor, Metropolitan Magistrate, Kanpur Nagar , may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Kanpur Nagar, for kind perusal and order to the effect that copy of aforesaid letter dated 11.08.2020 along with attested copies of mark-sheet and degree of LL.M. (**online attached on 07.01.2021**) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Bushra Noor, Metropolitan Magistrate, Kanpur Nagar, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
