May kindly see the online applications of Smt. Sushil Kumari, Civil Judge (Sr. Div.), Mohanlalganj at Lucknow regarding issuance of fresh 'No Objection/ Identity Certificate' in her favour for obtaining Passport.

In her application, Smt. Sushil has stated that she got 'No objection/ Identity Certificate' vide letter no 9293/IV-Admin (A)/Dated 15.7.15 but due to some personal reasons she could not apply for passport. Sri Manoj Kumar Yadav (Husband), Master Nithik Yaduvanshi and Master Medhaush (Sons) are dependent family members of the officer. She has also enclosed required details/ declaration on 'Affidavit' and also returned earlier issued 'Identity Certificate' which may kindly be seen as attachments. in duplicate, under the signature of Registrar (Judicial) (Budget) in favour of Smt. Sushil Kumari, Civil Judge (Sr. Div.), Mohanlalganj at Lucknow, as requested, with the direction that she may now apply for issuance of fresh Passport within due time and she should take prior permission of the Court before proceeding abroad??
