May kindly see letter dated 02.09.2020 alongwith attested copies of mark-sheets (all semesters) and degree of LL.M (online attached on 02.09.2020) of Sushri Anukriti Singh, Addl. Civil Judge (Junior Div.) Raibareli, requesting for inclusion of LL.M qualification in her service-records and grant of three advance increments. Sushri Anukriti Singh, aforesaid, had earlier requested for inclusion of LL.M qualification in her service-records and grant of Three Advance Increments vide District Judge, Raebareli on 02.09.2020 (online mode). Further, she has uploaded attested copies of mark-sheets (all semesters) and degree of LL.M. qualification (online attached on 02.09.2020).

In this context, it is submitted that Sushri Anukriti Singh, aforesaid, joined U.P.Judicial Services on 15.11.2019 as Addl. Civil Judge (Junior Div.), Raebareli. Besides, as apparent from submitted attested copies of mark-sheet and degree of LL.M (online attached on 02.09.2020), Sushri Anukriti Singh, completed LL.M course in year 2019 and was subsequently awarded Degree from Lucknow University, Lucknow on 15.10.2019. Nevertheless, relevant detail about course completion is not mentioned in her application form of U.P.Nyayik Sewa/UPHJS, thus, said qualification is required to be included in her service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M degree, may be included in the service records of Sushri Anukriti Singh , aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 02.09.2020(online attached on 02.09.2020) of Sushri Anukriti Singh, Addl. Civil Judge (Junior Div.) Raibareli , may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may be laid before Hon'ble Mr. Justice Vivek Agarwal, Administrative Judge, Raebareli, for kind perusal and order to the effect that copy of aforesaid letter dated 02.09.2020 along with attested copies of mark-sheets and degree of LL.M. (online attached on 02.09.2020) as well as attested copy of form of U.P.Nyayik Sewa of Sushri Anukriti Singh, Addl. Civil Judge (Junior Div.) Raibareli, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
