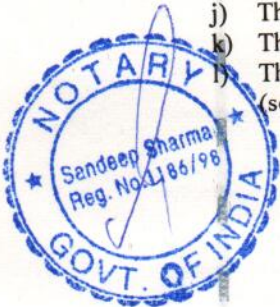

- g) That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
