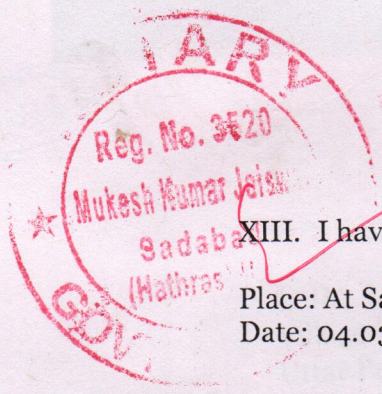
- I. I am a citizen of India.

 - X. The issue of a passport or travel document to me will not prejudice the public interest.
 - XI. There is no possibility of arising embarrassing position before government of Uttar Pradesh due to my visit to any foreign country.
