Re: Removal Of objections (by Admin.4) in respect to permission to pursue two years LL.M Course (2019-2021):
Sir,

It is humbly submitted that I have applied for permission to pursue two year LL.M Court (Correspondence Mode) academic years 2019-2020 & 2020-2021 from Kurukshetra University,Haryana .The following objections have been raised by the Admin-4 Section of Hon'ble High Court.I beg to submit the following as to the removal of the said objections in pointwise manner ;

Objection- 1-

"The officer may kindly be asked to intimate about the academic Session of her complete LL.M Course and also upload prospectus and a declaration saying that she may do/pursue the course without attending day to day class."

Removal of aforesaid objection No.-1:

The said LL.M Course is a correspondence Course duly conducted by the reputed Kurukshetra University,Kurukshetra Haryana. The Academic Session of two year Course is from 2019-2021.The duration of the Course is of two year.The present examination relates to year 2019-2020 .The prospectus is being uploaded as available on the official website of the university. The required declaration as directed is annexed herewith as **Annexure-1..**

Objection- 2-

"She may also be asked to clarify why she informed so late about the exam and whether she would appear in the said examination for taking further action in the matter."

Removal of aforesaid objection No.-2:

The prime reason for the late information and application for permission is that the examination was uncertain due to prevailing Covid-19 ,Pandemic.The university itself decided belatedly that examination be conducted by internet towards the last week of August 2020 itself.Further ,I am in family way & there were complications relating to pregnancy .Further, the date of the child birth was not certain till 09-09-2020. All these factors were making the possibility of my appearance in the said examination via internet, a distant possibility .The examination has commenced from 11-09-20 and last of the six papers will be on 05 October 2020 .Now, that the child has taken birth ,I have become certain that I may appear in the rest four papers except the first two.Therefore ,in the changed circumstances ,I have decided to appear in the rest of the papers except the first two as I can appear in the said examination from my home itself via internet now and reappear in the left over papers later . Besides the aforesaid facts, a little delay has also occasioned due to frequent closure of the Courts at Ghaziabad due to Covid -19.

It is therefore submitted that I shall appear in the aforesaid LL.M examination papers scheduled for 28-09-2020,30-09-2020,03-10-2020 and 05-10-2020 respectively in this academic session 2019-2020 & in the second year academic session 2020-2021 as and when said examination of that session are held by the university .


It is therefore prayed that my aforesaid removal of objections may kindly be considered sympathetically and my prayer for permission to appear in the two years LL.M Course by correspondence mode academic year 2019-2021 from Kurukshetra University,Kurukshetra Haryana be kindly planced before the Hon'ble Court for kind consideration.
