**Subject: Reply to Objection raised on application for three additional increments in lieu of LLM degree before joining in UP Judicial Services.**

**Dated: 15.01.2021 at Bulandshahr**

Sir,

In respect of aforementioned subject it is hereby submitted that I had applied for three additional increments in lieu of Post Graduation Degree in Masters of Law via Online application No 1413 dated 14.12.2020. In this application Following objection has been raised by the Hon'ble Court,

*“In instant matter, Sri Prikshit, Addl. Civil Judge (Junior Div.) Bulandshahr, has uploaded attested photocopies of Degree and Marksheets of LLM qualification. Further, date as mentioned in the Degree of subject qualification is 30.09.2016 whereas the date of mark-sheet is 27.01.2017 which is of later date so not justified.*

***I, therefore, request you to kindly direct Sri Prikshit, aforesaid that he may kindly clarify the above said points/issues so that further necessary action may be taken in instant matter.”***

In reply to the aforesaid objection it is most respectfully submitted that the result of LLM Final Semester of the applicant was declared on 16.08.2016. But the applicant found that his Father's Name was not correctly mentioned in the result by

the esteemed University. (Copy of result downloaded from internet has been annexed with this application as Annexure – 1). The name of applicant's Father was mentioned as "Satish Kumar" while it ought to be "Satish Kumar Bajwan". Hence he had applied for correction in father's name, due to which the Detailed marksheet of applicant was re-issued with correct name on 27.01.2017. That is why the date of issue on DMC of 4<sup>th</sup> semester is later than the date of issue of Provisional Degree as well as final degree of LLM.

It is also humbly submitted that the applicant had also applied for correction in his detailed marksheets of Semester 2<sup>nd</sup> & 3<sup>rd</sup> of LLM, on same grounds, due to which they were also re-issued after the correction and bear the same date of re-issue i.e., 13.08.2016. (Copies of earlier DMCs of Semester 2<sup>nd</sup> and 3<sup>rd</sup> are Annexed as Annexure 2 & 3.) Hence the aforementioned contention of the applicant relating to the date of issue of final marksheet is further supported by these facts.

Hence, it is humbly submitted that please accept the same as disposal of the objection raised by the Hon'ble High Court of Judicature at Allahabad. I will be obliged to you for this act of grace.
