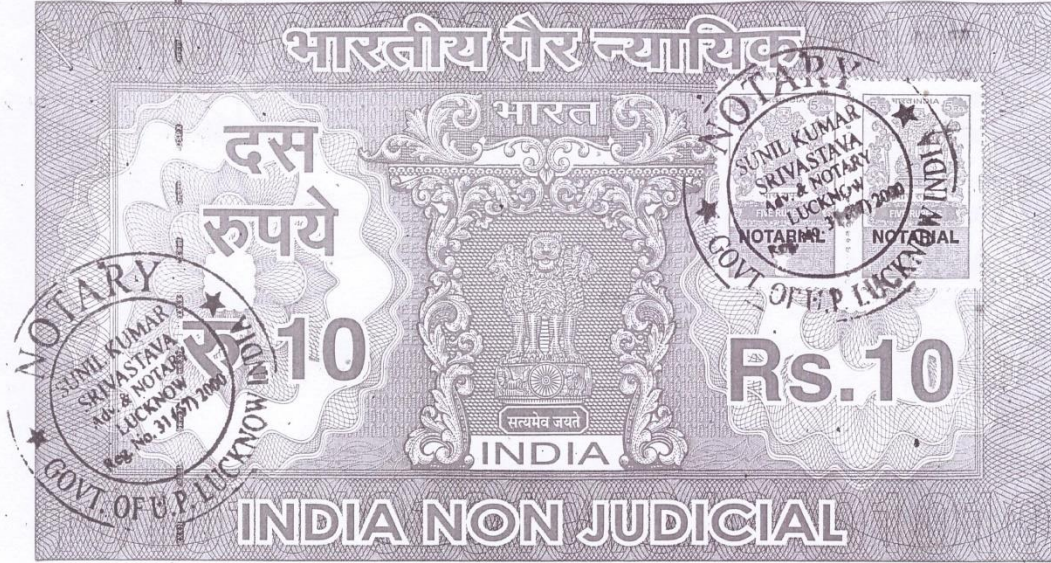

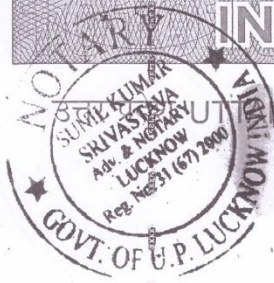
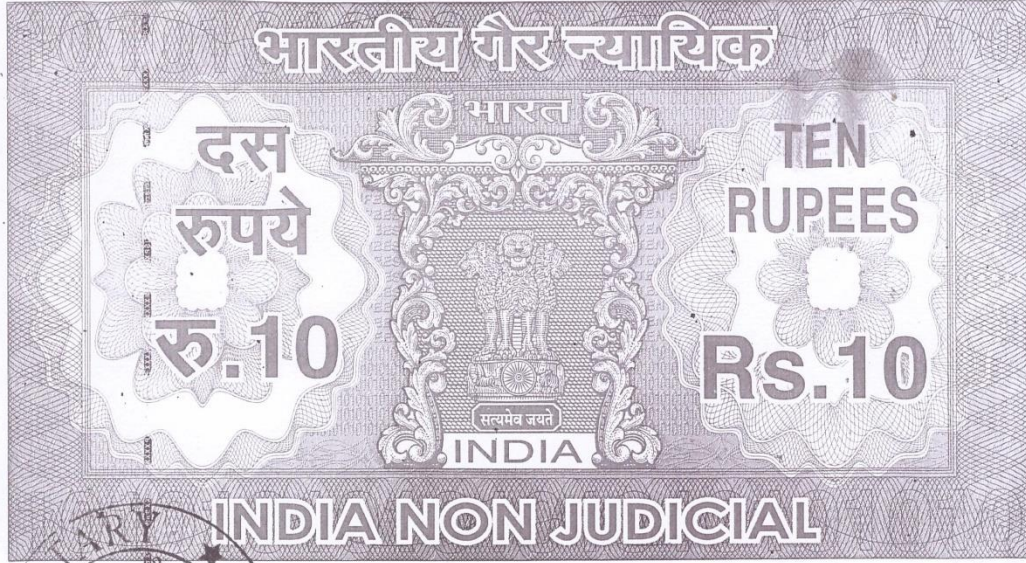
Affidavit of **SAPNA TRIPATI** SECRETARY U.P. STATE LAW COMMISSION LUCKNOW
