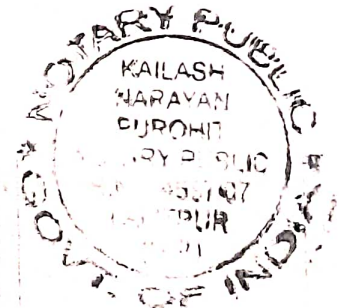
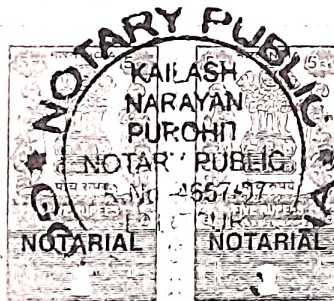
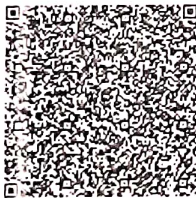

- (c) that the departure of applicant from India may not, or is not likely to, be detrimental to the security of India.




- ( ) that the presence of applicant outside India may not, or is not likely to, prejudice the friendly relations of India with any foreign country,




