**Subject: Submission of report in response to the query of the Hon'ble Court as is visible on the J.O. Portal regarding providing sale invoice of car purchased by me, regarding not obtaining of prior permission of the Hon'ble Court before accepting Rs.1,40,000/- from my real uncle for purchasing a car and regarding providing consent letter of my uncle.**

Respected Sir,

I most respectfully beg to submit my report on the subject noted above as under:

1. I belong to 2018 Batch of Civil Judges (Junior Division) and was posted by the Hon'ble Court in the District Court, Mahoba on 14.11.2019 and since then I continue to remain posted as such in the District Court, Mahoba.

2. I purchased a new car (Honda City) on 14.02.2020 from the Kanpur Nagar based reputed showroom M/S Smart Cars Pvt. Ltd , for a total price of Rs.13,51,000/-. Copy of sale invoice is annexed for perusal of the Hon'ble Court.
3. I paid the said price of the car by taking Rs.11,60,000/- as car loan on 11.02.2020 from the State Bank of India, Main Branch, Kanpur Nagar. I paid Rs.51,000/- from my salary account no. 20461531288 maintained with the State Bank of India, Main Branch, Kanpur Nagar and the remaining 1,40,000/- was gifted out to me by my real uncle Shri Savinay Kumar Shukla who runs his own cloth business in Kanpur Nagar, out of his saving bank a/c no. 27280100010378 maintained with the Collector Ganj branch of the Bank of Baroda through NEFT . A photostat copy of the bank statement of my uncle named above showing the aforesaid transaction is annexed for perusal of the Hon'ble Court. It is stated here that my father had died in 1997 and my said uncle managed the joint family and raised me as my true guardian in place of my deceased father.
4. I had already intimated the Hon'ble Court on 03.07.2020 regarding the purchase of the said car and had also sent the copies of necessary papers by disclosing therein that Rs.1,40,000/- was gifted out to me by my uncle named above through NEFT to purchase the said car.
5. I most humbly submit to the Hon'ble Court that being a new entrant in the judicial service, I was not familiar with the requirement of rules that prior permission of the Hon'ble Court was required before accepting the said amount of Rs.1,40,000/- from my uncle gifted out to me for purchase of the said car. Had I the idea of obtaining prior permission from the Hon'ble Court for accepting the said gift amount from my uncle, I would have obtained such permission from the Hon'ble Court beforehand. I most conscientiously assure the Hon'ble Court that henceforth no such lapse will ever take place on my part in future.

6. The Consent Letter of my uncle named above as required by the Hon'ble Court stating therein that he had given me the aforesaid amount of Rs.1,40,000/- through NEFT from his saving bank account as mentioned above as gift to me and not as loan or any other kind of money to be refunded to him is annexed for kind perusal of the Hon'ble Court.

The report as above is hereby being sent to the Hon'ble Court with the request to kindly accept the same. I shall remain grateful to the Hon'ble Court for this grace forever.
