
1. That the amount shall not be withdrawn unless it is actually required for the purpose and it shall not be utilized for any other purpose.

5. That as per undertaking dated nil, issued by Sri Satya Nand Upadhyaya under his own signature and seal, any excess payment made in his favour shall be returned by him immediately to the concerned authority/account.

I, thus, request you to kindly take necessary action in this matter, keeping in view the aforesaid conditions, at the earliest possible, under intimation to this Court.


