(h) That the applicant has not been ever repatraited.

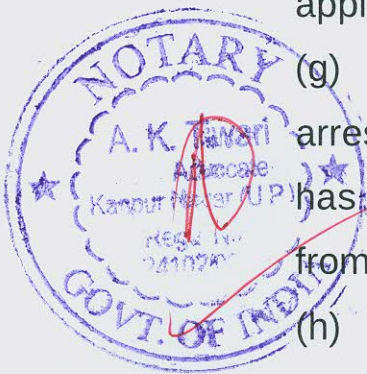
(i) That there will not be any possibility of arising embarrassing position before the Government of Uttar Pradesh due to applicant's visit to any foreign country.
