 - That, out of this Rs.12,00,000/- approximately Rs. 2,00,000/- are my savings.
 - That I had sold my Agricultural land measuring 0.510 hectare located at village Shahpur Kalan,

Kasba Hasanpur, Distt Amroha, U.P. for Rs. 59,99,905.60 with the permission of the Hon'ble High Court of Allahabad and out of which I have already paid Rs.50,00,000/- as advance to the seller of the house which I am going to purchase. The remaining Rs. 999905.60/- which is part of the aforesaid consideration is still in my account. (The complete details indicating all the entries have already been submitted on 15.09.2021.)

- ii. Salary/ Saving Bank Account No. 10125950311 in State Bank of India (Branch Delta 2, Greater Noida , Gautam Budh Nagar)
(As directed earlier attested copy of the passbook/ statement for more than 6 months starting from 1st Janauray, 2020 has already been submitted on 15.09.2021)
In this Account I have Rs.2,54,000/- as available balance which are my savings.

In view of the above submissions and supporting documents it is most humbly prayed to do the needful for the grant of permission to purchase residential house under case id. 2351.
