

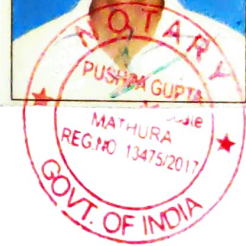
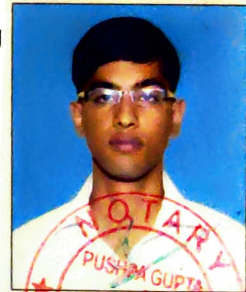

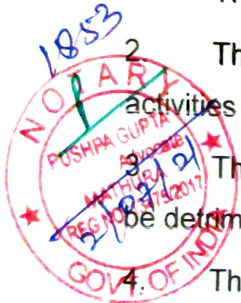

Affidavit for Issuance of Identity Certificate for Renewal of Passport

7. That a warrant or summons for the appearance, or a warrant for the arrest, of the applicant has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the applicant has not been made by any such court.
8. That the applicant has not been repatriated.
