

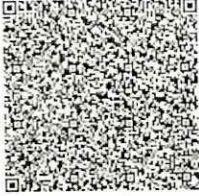

(k) I have not visited any foreign country earlier.

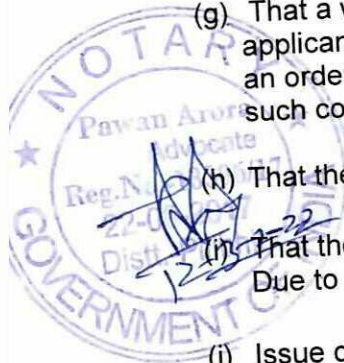
