Respected Sir,

With utmost regards, in reference to the request dated 04/04/2022 Application id (case id)-S00020232022, it is most humbly submitted that I, Nikita Sengar joined the Uttar Pradesh Judicial Services on 16/11/2019 at District Court Hardoi as per the notification of the Hon'ble High Court of Judicature at Allahabad through Notification no. 3842/Admin.(Services) 2019 dt. 14 November 2019.

I am currently working as Add. Civil Judge (J.D)-III, Hardoi. It is my honor to submit that in the last two years of my training and service I have been constantly enlightened in the field of law under the able supervision and guidance of the Hon'ble High Court of Judicature at Allahabad and IJTR, Lucknow. I express my heartfelt gratitude to the Honorable High Court for providing me with these exceptional learning opportunities.

It is further submitted that vide Notification No.9/2020-RC, dated 30.03.2022 (copy enclosed as Annexure 1) of High Court of Andhra Pradesh at Amravati I have been selected for the post of Civil Judge (Junior Division) in the Andhra Pradesh State Judicial Services. It is most humbly submitted that the **reason for joining** the Andhra Pradesh State Judicial Services is that my husband is an IPS officer serving in Andhra Pradesh cadre. It is further submitted that I had taken prior permission of The Hon'ble High Court of Judicature at Allahabad before appearing for the Andhra Pradesh Judicial Services exam vide case id S00013352021 dated 22-09-2021 (copy enclosed as Annexure 2) and also No Objection Certificate for appearing for the interview of Andhra Pradesh State Judicial Services exam was obtained from this Hon'ble court on 02/03/2022 (copy enclosed as Annexure 3).

The dates for joining The Andhra Pradesh State Judicial Services have not been notified yet but the process is likely to start in the month of May 2022. I, therefore, hereby tender my resignation from Uttar Pradesh Judicial Service in accordance with Rule-3 of the U.P. Temporary Government Servants (Termination of Services) Rules, 1975.

It is most humbly requested to accept my resignation and relieve me so as to enable me to join Andhra Pradesh Judicial Services. I request you to kindly waive off my notice period of one month so that I may be able to join Andhra Pradesh Judicial Services at the earliest. I most humbly plead that my resignation be considered effective from 01/05/2022.

It is further submitted that I have written a letter to the Hon'ble Governor of Uttar Pradesh humbly beseeching to relieve the undersigned from the duties to enable her to join Andhra Pradesh Judicial Services. The above mentioned letter has been duly annexed with this application.
