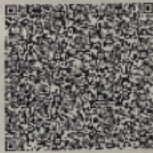

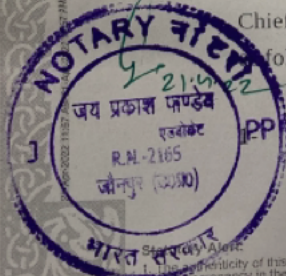

(I) There is no possibility of arising embarrassing position before Government of U.P. due to her visit to any foreign country.

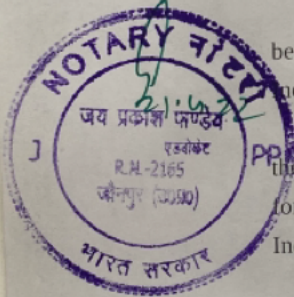
(J) I have never been refused or denied issuance of 'Identity Certificate' for obtaining a passport.
