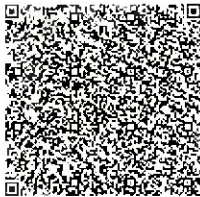

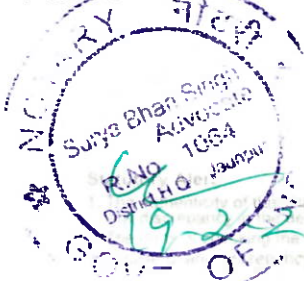

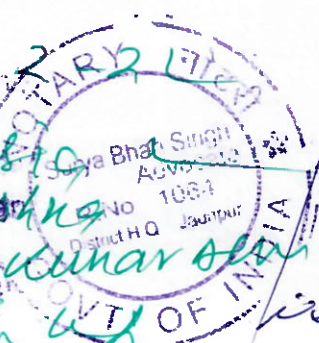
2. That I am a citizen of India by birth and that I have neither acquired the citizenship of another country nor have surrendered nor been terminated/deprived of my citizenship of India.
